# PLEASE READ THESE TERMS CAREFULLY AND IN FULL. THEY CONTAIN CONDITIONS AND RESTRICTIONS ON THE AVAILABILITY OF THE DISNEY+ OFFER.

The Offer is brought to you by Visa International Service Association and affiliates ("Visa", "we", "our", "us"). By using this Offer, you indicate acceptance of these rules together with any specific instructions and terms for such promotion which may be mentioned in any electronic messages, on the website, or communicated to you in any other way.
